that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 6.348 cubic foot per second if available at the original point of diversion in the SE 1/4 SW 1/4, Section 11, T2N, R27E, WM; 970 feet North and 450 feet West from the South Quarter Corner, Section 11.

The point of diversion is located in the $\,$ NE 1/4 SE 1/4, Section 2, SE 1/4 SW 1/4, Section 11, T2N, R27E, WM; 50 feet South and 350 feet West from the E 1/4 Corner, Section 2; 970 feet North and 450 feet West from the S 1/4 Corner, Section 11.
