and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 8 , at page 1 ; that the priority of the right thereby confirmed dates from June, 1905

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.0 acre-feet per acre in any irrigation season, diverted at a rate of not to exceed one-fortieth of a cubic foot per second per acre, if available at the original point of diversion in the SE 1/4 SW 1/4, Section 3, T4S, R39E, WM (Godley No. 2 Ditch).

The point of diversion is located in the SE 1/4 SW 1/4, Section 3, T4S, R39E, WM; SW 1/4 SW 1/4, Section 27, T3S, R39E, WM; 1150 feet North and 2750 feet West from the SE Corner, Section 3 (Godley No. 2 Ditch); 660 feet North and 1100 feet East from the SW Corner, Section 27 (Pump).

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm an additional point of diversion approved by an order of the Water Resources Director entered September 12, 1977 and together with certificate of water right recorded at page 45221, of Water Right Certificates, Volume 37, State Record Certificate 6151.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
