CERTIFICATE OF WATER RIGHT

This is to certify, That EVERETT D. CULVER

of HC 85, Box 126, Myrtle Point, State of Oregon 97458, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two springs and Middle Fork Coquille River

a tributary of Coquille River for the purpose of irrigation of 20.0 acres and domestic use for two families, including the irrigation of lawn and garden not to exceed one-half acre in area under Permit No. 38129 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 18, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.27 cubic foot per second, being 0.02 cfs for domestic from springs, and 0.25 cfs for irrigation from the river

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 NE 1/4, Section 35, Lot 14 (SE 1/4 SW 1/4), Lot 12 (NW 1/4 SW 1/4), Lot 11 (NE 1/4 SW 1/4), Section 36, T29S, R11W, WM. Spring 1 - 250 feet South and 1800 feet West from NE Corner, Section 35, Spring 2 - 620 feet North and 2080 feet East, River 3 - 2200 feet North and 350 feet East, River 4 - 1970 feet North and 2640 feet East, *

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

*all from SW Corner, Section 36.

- 4.2 acres Lot 11 (NE 1/4 SW 1/4)
- 8.0 acres and domestic Lot 12 (NW 1/4 SW 1/4)
- 0.3 acre Lot 9 (NE 1/4 SE 1/4)
- 7.5 acres and domestic Lot 10 (NW 1/4 SE 1/4)
- Section 36
- Township 29 South, Range 11 West, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
