CERTIFICATE OF WATER RIGHT

This Is to Certify, That

WILLIAM J. AND BARBARA BOWERMAN

of 2300 Oakmont Way, Eugene, State of Oregon 97401, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of John Day River

a tributary of Columbia River for the purpose of irrigation of 273.9 acres

under Permit No. 41914 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 10, 1977 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 6.85 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 SE 1/4, SE 1/4 SW 1/4, Section 9, SW 1/4 NE 1/4, Section 16, NW 1/4 NW 1/4, Section 22, T8S, R19E, WM; Diversion No. 1 - 1380 feet North and 1200 feet West, No. 2 - 410 feet North and 2720 feet West, No. 3 - 2180 feet South and 2430 feet West, all from SE Corner, Section 9, No. 4 - 530 feet South and 740 feet East, from NW Corner, Section 22

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
