CERTIFICATE OF WATER RIGHT

This is to certify, That AL CONFORTH

of PO Box 38, Umatilla, State of Oregon 97882, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of three wells

a tributary of Columbia River for the purpose of irrigation of 112.8 acres

under Permit No. G-6630 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 2, 1976

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

1.41 cubic feet per second, being 0.31 cfs from Well 1, 0.64 cfs from Well 2, and 0.46 cfs from Well 3

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the Well 1 and 2 - NW 1/4 NW 1/4, Section 22; Well 3 - NW 1/4 SW 1/4, Section 15, T5N, R29E, WM; Well 1 - 2400 feet North and 370 feet East; Well 2 - 2540 feet North and 720 feet East; both from W 1/4 Corner, Section 22; Well 3 - 2100 feet North and 420 feet East from SW Corner, Section 15.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
