## CERTIFICATE OF WATER RIGHT

This is to certify, That ROBERT L. COATS

of 63285 Skyline Ranch Road, Bend , State of Oregon 97701 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well South Fork of Crooked River for the purpose of a tributary of irrigation of 420.3 acres under Permit No. G-9397 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 4, 1980 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 5.25 cubic feet per second or its equivalent in case of rotation, measured at the point of diversion from the well. The well is NW 1/4 NW 1/4, Section 17, T21S, R20E, WM; 1280 feet

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
