CERTIFICATE OF WATER RIGHT

, State of Oregon 97321 of 316 6th Avenue SW, Albany , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Willamette River Columbia River for the purpose of a tributary of irrigation of 57.7 acres under Permit No. 46321 and that said right to the use of said waters has been perfected in $accordance\ with\ the\ laws\ of\ Oregon;\ that\ the\ priority\ of\ the\ right\ hereby\ confirmed\ dates\ from$ April 16, 1980 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.72 cubic foot per second $or\ its\ equivalent\ in\ case\ of\ rotation,\ measured\ at\ the\ point\ of\ diversion\ from\ the\ stream.\ The\ point\ of\ diversion\ from\ the\ stream.$ NE 1/4 SW 1/4, Section 1, TllS, R4W, WM; diversion is located in the 220 feet North and 150 feet West from NW Corner, Montieth DLC 55. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 11.1 acres SW 1/4 SW 1/4 as projected within Gordon DLC 5418.5 acres SE 1/4 SW 1/4 as projected within Gordon DLC 54 10.8 acres SE 1/4 SW 1/4 as projected within Montieth DLC 55 16.8 acres SW 1/4 SE 1/4 as projected within Montieth DLC 55 Section 1 0.5 acre NW 1/4 NE 1/4 as projected within Montieth DLC 55 Section 12 Township 11 South, Range 4 West, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
