CERTIFICATE OF WATER RIGHT

This is to certify, That KEITH PATRICK GAYNOR

of Box 13, Weaver Road, Myrtle Creek, State of Oregon 97457, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of an unnamed stream

a tributary of South Umpqua River for the purpose of irrigation of 2.3 acres

under Permit No. 40263 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 8, 1976

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (NE 1/4 NW 1/4); NE 1/4 NW 1/4 as projected within Bailey DLC 40, Section 6, T30S, R5W, WM; 670 feet South and 430 feet West; 1310 feet South and 110 feet West, both from North Quarter Corner, Section 6.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 0.7 acre SW 1/4 NE 1/4 as projected within Weaver DLC 39
 - 0.4 acre SW 1/4 NE 1/4 as projected within Bailey DLC 40
 - 0.3 acre NE 1/4 NW 1/4 as projected within Bailey DLC 40
 - 0.8 acre SE 1/4 NW 1/4 as projected within Bailey DLC 40
 - 0.1 acre SE 1/4 NW 1/4 as projected within Weaver DLC 39
- Section 6
Township 30 South, Range 5 West, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
