CERTIFICATE OF WATER RIGHT

This is to certify, That ROY ALLEN AND VIRGINIA LOUISE HERGERT

of 28357 N.W. Williams Canyon Rd., Gaston, State of OR 97119, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of an unnamed stream and two springs

a tributary of Tualatin River for the purpose of irrigation of 1.5 acres, stock use, and domestic use for one family

under Permit No. 43961 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 18, 1978

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.03 cubic foot per second; being 0.02 cfs for irrigation, 0.003 cfs for stock from the stream, 0.0045 cfs for domestic use for one family from spring No. 1, and 0.0005 cfs for domestic, and 0.002 cfs for stock from spring No. 2

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 SW 1/4, Section 4, T2S, R4W, WM; Spring No. 1: 1000 feet North and 160 feet East; Spring No. 2: 700 feet North and 180 feet East; Unnamed Stream: 1100 feet North and 380 feet East; all from the SW Corner of Section 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further water shall not be appropriated during the period from July 31 through September 15 of each year except for human and livestock consumption

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Domestic, Stock, and 1.5 acres
SW 1/4 SW 1/4
Section 4
Township 2 South, Range 4 West, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
