CERTIFICATE OF WATER RIGHT

This is to certify, ThatADRIAN C. HALTER
c/o Ethel E. Halter

of Box 63, Arago Station, Myrtle Point, State of Oregon 97468, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Coquille River

a tributary of Pacific Ocean for the purpose of irrigation of 103.5 acres

under Permit No. 38796 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 29, 1975 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.29 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 SE 1/4, Section 24, NE 1/4 NW 1/4, NW 1/4 NW 1/4, Section 25, T28S, R13W, WM; Diversion 3 - 500 feet North and 2700 feet East, Diversion 2 - 500 feet South and 1650 feet East, Diversion 1 - 780 feet South and 650 feet East, all from NW Corner, Section 25.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighthieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
