CERTIFICATE OF WATER RIGHT

This Is to Certify, That VICTOR J. RICE

of Box 11, Myrtle Creek, , State of Oregon 97457 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of North Myrtle Creek

a tributary of South Umpqua River for the purpose of irrigation of 9.7 acres

under Permit No. 27879 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 1, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.126 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 NW 1/4, Section 24, T29S, R5W, WM; 2180 feet South and 1020 feet West from NE corner, Jones DLC 48.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to use of water is limited to the period when the flow of the South Umpqua River is more than 60 cfs at its mouth;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.9 acres SE 1/4 SW 1/4 as projected within Jones DLC 48
Section 13

3.1 acres NE 1/4 NW 1/4 as projected within Jones DLC 48
1.6 acres NW 1/4 NW 1/4 as projected within Jones DLC 48
0.1 acre Lot 5 (NW 1/4 NW 1/4)
Section 24
Township 29 South, Range 5 West, WM

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 51570, Volume 46, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on January 13, 1986, approving transfer application No. 5668.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
