CERTIFICATE OF WATER RIGHT

This Is to Certify, That CHESTER R. LONGBRAKE

of 130 Elder Mill Road, Trail, State of Oregon 97541, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of north unnamed stream, south unnamed stream, and Longbrake Reservoir constructed under Permit R-5826 a tributary of East Fork Trail Creek for the purpose of irrigation of 17.7 acres and supplemental irrigation of 11.7 acres

under Permit No. 35991 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 24, 1971

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.23 cubic foot per second, being 0.10 cfs from north unnamed stream and 0.13 cfs from south unnamed stream

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 SW 1/4, Section 3, NE 1/4 SE 1/4, NW 1/4 SE 1/4, Section 4, T33S, R1W, WM; north stream- 1740 feet North and 780 feet East from SW Corner, Section 3; south stream- 1340 feet North and 580 feet West; reservoir- 1340 feet North and 1540 feet West, both from SE Corner, Section 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-5826;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
