CERTIFICATE OF WATER RIGHT

This is to certify, That

WILLIAM G. HARRIS

of 4025 Jumpoff Joe Cr Rd, Grants Pass , State of Oregon 97526 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Jumpoff Joe Creek

a tributary of Rogue River irrigation of 8.5 acres

for the purpose of

under Permit No. 25890 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 27, 1958

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.14 cubic foot per second, if available at the original point of diversion in NW 1/4 NW 1/4, Section 4, T35S, R5W, WM; 1250 feet South and 320 feet East from NW Corner, Section 4.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 NE 1/4, Section 5, T35S, R5W, WM; 1000 feet South and 550 feet West from NE Corner, Section 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and is subject to a stipulation with the Oregon State Game Commission recorded at page 52 and 53, Volume 4, Miscellaneous Records of the Water Resources Department.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.5 acres SE 1/4 SE 1/4
Section 32
Township 34 South, Range 5 West, WM

7.0 acres NE 1/4 NE 1/4
Section 5
Township 35 South, Range 5 West, WM

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered November 23, 1982, and together with certificate of water right recorded at page 52993, Volume 48, State Record of Water Right Certificates, supersedes Certificate 44961.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
