CERTIFICATE OF WATER RIGHT

This is to certify, That DOUGLAS A. AND JUDY P. NIELSEN

of 259 SW 137th, Seattle, State of WA 98166, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of North Santiam River and Detroit Reservoir constructed under Permit R-1625

a tributary of Santiam River for the purpose of irrigation of 25.7 acres

under Permit No. 39888 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 12, 1975 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.32 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (SE 1/4 SW 1/4), Section 22, T9S, R2E, WM; 120 feet North and 610 feet East from the NW Corner, John B. Potter DLC 37. Detroit Reservoir - SW 1/4 NW 1/4, Section 7, T10S, R5E, WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year, from direct flow and storage from resevoir constructed under Permit R-1625, and is subject to the terms and conditions of Contract 5-07-10-W0540 or a satisfactory replacement between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 0.2 acre SE 1/4 SW 1/4 as projected within John B. Potter DLC 37
1.6 acres SW 1/4 SE 1/4 as projected within John B. Potter DLC 37 Section 22
16.4 acres NW 1/4 NE 1/4 as projected within John B. Potter DLC 37
7.5 acres NE 1/4 NW 1/4 as projected within John B. Potter DLC 37 Section 27
Township 9 South, Range 2 East, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
