and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Baker County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at page 291; that the priority of the right thereby confirmed dates from August 28, 1880

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one-fortieth of one cubic foot per second per acre if available at the original point of diversion in SE 1/4 NE 1/4, Section 34, T7S, R38E, WM; Favorite Ditch-400 feet North and 400 feet West from East 1/4 Corner, Section 34.

The point of diversion is located in the SE 1/4 NE 1/4, Section 34, SW 1/4 NW 1/4, Section 35, T7S, R38E, WM; 1-Toney Blize Ditch- 460 feet North and 250 feet West; 2-Favorite Ditch- 400 feet North and 400 feet West; 3-Toney Ditch-710 feet North and 1130 feet East, all from West 1/4 Corner, Section 35.
