CERTIFICATE OF WATER RIGHT

This is to certify, That

of 15134 Old Mehama Rd. S.E., Stayton , State of OR 97383 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Detroit Reservoir constructed under Permit No. R-1625

a tributary of North Santiam River irrigation of 65.9 acres

for the purpose of

under Permit No. 41649 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 29, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 144.05 acre-feet stored water only

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NW 1/4, Section 7, TlOS, R5E, WM, Detroit Reservoir. Re-diversions from North Santiam River located: Lot 9 (NW 1/4 NE 1/4), Section 13, T9S, RlW, WM, Lot 4 (NW 1/4 NW 1/4), Section 18, T9S, RlE, WM; 720 feet South and 1670 feet West, 1000 feet South and 420 feet East, both from the NE Corner, Section 13, T9S, RlW, WM.

The amount of water used for irrigation, together with the amount secured under any other right

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, and shall be further limited to a diversion of 2 1/2 acre-feet for each acre irrigated during the irrigation season of each year, and is subject to the terms and conditions of contract No. 7-07-10-W0013, or a satisfactory replacement between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

20.4 acres NE 1/4 SE 1/4
10.3 acres NW 1/4 SE 1/4 as projected within Hause DLC 49
24.4 acres SE 1/4 SE 1/4

10.8 acres NE 1/4 NE 1/4

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
