under Permit No. 41585 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 8, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.91 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of is located in the Lot 7 (NE 1/4 SW 1/4), Section 9, T11S, diversion is located in the R4W, WM; 1980 feet North and 1850 feet East from the SW Corner, Section 9.

The amount of water used for irrigation, together with the amount secured under any other right one-eightieth of one cubic foot per second per existing for the same lands, shall be limited to or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer.
