CERTIFICATE OF WATER RIGHT

This is to certify, *That* CHARLES D. AND JANE C. WAVRA

of 8167 Oak Lane NE, Mt. Angel, State of Oregon 97362, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Well #1 and #2

a tributary of Little Pudding River for the purpose of irrigation of 121.0 acres and supplemental irrigation of 177.3 acres

under Permit No. G-7901 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 22, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.48 cubic feet per second, being 1.24 cfs from each well

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the #1 - SW 1/4 SW 1/4, #2 - SE 1/4 SW 1/4, both within Section 11, T8S, R2W, WM; 1800 feet South and 1850 feet West, 1750 feet South and 950 feet West, both from the SW Corner, Waldo DLC 41.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that in the event of a request for a change in points of appropriation, an additional point of appropriation or repair of these wells, the quantity of water allowed herein together with any other right from these points of appropriation shall not exceed the capacity of these wells at the time of perfection of this right. and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
