## CERTIFICATE OF WATER RIGHT

## This is to Certify, That Jesse L. Neil

of Ashland , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Grizzly or Beaver Creek, Hoxie Creek, Willow Creek, No Name Creek, and Swinning Spring a tributary of Jenny Creek (Klamath Riverfor the purpose of Irrigation under Permit No. 6696 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 13, 1925;

that the amount of water to which such right is criticled and hereby confirmed, for the purposes accressed, is limited to an amount actually beneficially used for said purposes, and shall not exceed

## 2.31 cabic feet per second;

The use he cander for irrigation shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent in case of rotation.

A description of the lands irrigated under the right hereby confirmed, and to which such right is appurtenant (or, if for other purposes, the place where the water is put to beneficial nec), is as follows: 12 acres in the Northwest Quarter of the Southwest Quarter (M/SWA), and 9 acres in the Southwest Quarter of the Southwest Quarter (SWASWA) of Section Thirty (30); 28 acres in the Northwest Cuarter of the Northwest Quarter (NVANVA), 35 acres in the Northeast Quarter of the Northwest Quarter (MELNAL), 8 acres in the Northwest Quarter of the Northeast Quarter (NVLNEL), acros in the Southeast Quarter of the Northwest Quarter (SEINA), 12 acres in the Southwest Cuarter of the Northwest Quarter (SWANWA), 14 acres in the Northeast Quarter of the Southeast Quarter (NE2SE2), 12 acres in the Northwest Quarter of the Southeast Cuarter (NW2SE2), 24 acres in the Southwest Quarter of the Southeast Quarter (SW2SE2) of Section Thirty-one (31), Township Thirty-eight South, Range Four East, W. M.; 18 acres in the Northeast Quarter of the Northeast Quarter (NE NE and 9 acres in the Northwest Quarter of the Northeast Quarter (Note: Note: Section Thirty-six (36), Township Thirty-eight South, Range Three East of the Willamette Meridian, in Jackson County, Oregon, being a total of 185 acres.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby continued and limited.
