## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** SIDNEY IRRIGATION COOPERATIVE

of P.O. Box 736, Jefferson, , State of Oregon 97352 , has  
a right to the use of the waters of North Santiam River

a tributary of Santiam River for the purpose of  
irrigation of 2,000.0 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for  
Marion County, and the said decree entered of record at Salem, in the Order Record of  
the WATER RESOURCES DIRECTOR, in Volume 18 , at page 437 ; that the priority of the  
right thereby confirmed dates from May 14, 1909

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an  
amount actually beneficially used for said purposes, and shall not exceed 25.00 cubic foot  
per second.

NOTE: To compensate for losses between the point of diversion to the place of  
use, an additional amount not exceeding ten percent is allowed.

The point of diversion is located in the SW 1/4 NE 1/4 within Chamness DLC 59  
Section 34, T9S, R2W, WM being 50 feet North and 1930 feet East from East 1/4  
corner Section 34.
