## CERTIFICATE OF WATER RIGHT

This is to certify, That

DELMAR C. and SUSAN M. ROBISON

of Rt. 1, Box 2072, Bandon , State of OR 97411 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of an unnamed stream, reservoir, and sumphole constructed under Permit No. R-4792

a tributary of Conners Creek irrigation and frost control of 1.4 acres

for the purpose of

under Permit No. 31586 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 31, 1966

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.25 cubic foot per second; being 0.04 cfs for irrigation and 0.21 cfs for frost control

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 SE 1/4, Section 12, T30S, R15W, WM; Reservoir: 320 feet North and 160 feet East; Sumphole: 450 feet North and 200 feet East, both from S 1/4 Corner, Section 12.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to one-eightieth of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.4 acres and Frost Control SW 1/4 SE 1/4
Section 12
Township 30 South, Range 15 West, WM

SUPERSEDED BY CERT. NO. 87984

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
