CERTIFICATE OF WATER RIGHT

This is to certify, That GERALD P. and KATHLEEN A. MULLEN

of 17792 River Rd. NE, St. Paul, State of OR 97137, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Mission Creek and Mission Creek Reservoir, constructed under Permit No. R-5248

a tributary of Champoeg Creek for the purpose of irrigation of 79.7 acres

under Permit No. 39064 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 9, 1974 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.00 cubic foot per second from Mission Creek and 75.01 acre-feet from Mission Creek Reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 7 (SE 1/4 SE 1/4), Section 8 (Mission Creek Reservoir) NE 1/4 NW 1/4, as projected within Hickey DLC 67, Section 17, T4S, R2W, WM, Pump Located: 1900 feet North and 450 feet West from the SE Corner Hickey DLC 67.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-5248

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 1.5 acres NE 1/4 SW 1/4
0.7 acre SW 1/4 SW 1/4
30.8 acres SE 1/4 SW 1/4
1.1 acres NW 1/4 SE 1/4
12.8 acres SW 1/4 SE 1/4
All as projected within Hickey DLC 67
Section 8
0.2 acre NW 1/4 NE 1/4
20.1 acres NE 1/4 NW 1/4
12.5 acres NW 1/4 NW 1/4
All as projected within Hickey DLC 67
Section 17
Township 4 South, Range 2 West, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
