CERTIFICATE OF WATER RIGHT

This is to certify, That

of 8158 Stayton Rd. SE, Turner , State of OR 97392 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two wells

a tributary of North Santiam River irrigation of 73.69 acres

for the purpose of

under Permit No. G-7271 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 24, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.92 cubic foot per second; being 0.41 cfs from well no. 1 and 0.51 cfs from well no. 3

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE 1/4 SE 1/4, Section 26, T9S, R2W, WM; Well No. 1: 1480 feet South and 1030 feet West, Well No. 3: 2040 feet South and 600 feet West, both from SE Corner, Section 26

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
