## CERTIFICATE OF WATER RIGHT

under Permit No. G-5777 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 27, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.88 cubic foot per second; being 0.11 cfs from each well

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NW 1/4 NE 1/4 and SW 1/4 NE 1/4, both as projected within Black DLC 51, Section 20, TlN, R3W, WM; Wells Loc: #1-1830'S & 270'W; #2-1720'S & 130'W; #4-1580'S & 260'W; #5-1650'S & 500'W; #6-1770'S & 900'W; #7-1870'S & 1320'W; #8-1230'S & 900'W; #9-560'S & 1000'W; all from NE corner, Black DLC 51.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
