CERTIFICATE OF WATER RIGHT

This Is to Certify, *That* A. C. PIERCE

of Box 99, Pierce Heights, Medford, State of OR 97501, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Squaw Creek and an unnamed stream

a tributary of Applegate River for the purpose of irrigation of 15.5 acres and domestic use for 3 families and stock

under Permit No. 28213 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 24, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.21 cubic foot per second, being 0.19 cfs from Squaw Creek for irrigation and 0.02 cfs from unnamed stream for domestic and stock, if available from the streams original diversion point; SE 1/4 SW 1/4, Section 1, T41S, R3W, WM: *

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 SE 1/4, NW 1/4 SE 1/4, SE 1/4 SW 1/4, Section 1, T41S, R3W, WM; Squaw Creek - 70 feet South and 720 feet West, 700 feet South and 2070 feet West both from E1/4 corner Section 1, Stream - 2310 feet South and 1730 feet East from W1/4 corner Section 1

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right to use of water for irrigation shall be limited to the period when the flow of the Rogue River is more than 735 cfs at its mouth,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

*2190 feet South and 1760 feet East from W1/4 corner Section 1.

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 37715, Volume 29, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on June 12, 1975, approving transfer 3195 and is issued to confirm a change in point of diversion approved by the same order and supersedes certificate 37715

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to minimum flows established by the Water Resources Commission with an effective prior to this right.
