CERTIFICATE OF WATER RIGHT

This is to certify, That MARTIN G. BAUER

of 199 Steelhead Lane, Grants Pass, State of OR 97527, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean for the purpose of irrigation of 3.4 acres

under Permit No. 10563 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 4, 1932

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.042 cubic foot per second, if available at the original point of diversion: NW 1/4 NW 1/4, Section 25, T35S, R7W, WM; 710 feet South and 200 feet East from NW corner Section 25

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (NE 1/4 SE 1/4) Section 23, T35S, R7W, WM; 2100 feet North and 700 feet West from SE corner Section 23.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.4 acres NE 1/4 SE 1/4 Section 23 Township 35 South, Range 7 West, WM.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered January 28, 1980, and together with certificate of water right recorded at page 49048, Volume 42, State Record of Water Right Certificates, supersedes certificate 47294.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
