CERTIFICATE OF WATER RIGHT

This Is to Certify, *That* ARNOLD A. AND CATHERINE PITTS

of 2819 Jumpoff Joe Creek Road, Grants Pass, State of OR 97526, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of unnamed gulch

a tributary of Jumpoff Joe Creek for the purpose of irrigation of 3.9 acres

under Permit No. 23692 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 3, 1955

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 SE 1/4, Section 31, T34S, R5W, WM; 75 feet North and 1220 feet East from S1/4 corner Section 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Township 34 South, Range 5 West, WM.

Land on which water is to be used is part of that described as follows:
Commencing at the NW corner stake of Lot of School
District No. 29 at Winona, running West 198 feet;
thence South 1320 feet; thence 198 feet East;
thence North 1320 feet to said stake at the place
of beginning

This certificate is issued to confirm a change in place of use approved by an order of the Water Resources Director entered November 9, 1982, and supersedes certificate of water right recorded at page 26788, Volume 19, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
