CERTIFICATE OF WATER RIGHT

This is to certify, That G. F. PATTERSON

of 7391 N. Myrtle Road, Myrtle Creek , State of OR 97457 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of North Myrtle Creek

a tributary of South Umpqua River irrigation of 2.3 acres

for the purpose of

under Permit No. 22843 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 1. 1954

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 SE 1/4, Section 5, T29S, R4W, WM; 1460 feet North and 320 feet East from S 1/4 corner Section 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.2 acres NW 1/4 SF 1/4

2.2 acres NW 1/4 SE 1/4 0.1 acre SW 1/4 SE 1/4 Section 5

Township 29 South, Range 4 West, WM

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered March 12, 1979, and together with certificate of water right recorded at page 50129, Volume 44, State Record of Water Right Certificates, supersedes certificate of water right recorded at page 23273, Volume 16, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
