CERTIFICATE OF WATER RIGHT

This is to certify, That ARIE JONGENEEL

of 16153 Marquam Road, Mt. Angel, State of OR 97362, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well

a tributary of Butte Creek for the purpose of irrigation of 56.2 acres

under Permit No. G-4179 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 11, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.33 cubic foot per second, if available at the original point of appropriation; SE 1/4 NE 1/4, Sec. 7, T6S, R1E, WM; 1350 feet South and 490 feet West from NE corner Section 7.

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE 1/4 NE 1/4, Sec. 7, T6S, R1E, WM; 2300 feet South and 1310 feet West from NE corner Section 7.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 25.0 acres SW 1/4 NE 1/4
- 29.8 acres SE 1/4 NE 1/4
- Section 7
- 1.4 acres Lot 2 (SW 1/4 NW 1/4)
- Section 8
- Township 6 South, Range 1 East, WM.

This certificate is issued to correctly describe the acreage mapped by the original final proof survey and supersedes certificate of water right recorded at page 49722, Volume 43, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
