that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.53 cubic foot per second, being 0.01 cfs from Read Creek and 0.52 cfs from Mary's River

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of within Wren DLC 54, Section 21, Tlls, R6W, WM; Read Creek - 500 feet North and 2850 feet East; Mary's River - 1140 feet South and 2910 feet East, both from West 1/4 Corner, Section 21. diversion is located in the

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
