## CERTIFICATE OF WATER RIGHT

**This is to certify, That** WILLIAM L. AND NADINE F. GALLAGHER

of Whiskey Creek Ranch, Box 898, Sprague River, State of OR 97639, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of one well

a tributary of Whiskey Creek for the purpose of irrigation of 253.0 acres

under Permit No. G-10021 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 27, 1982

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.16 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NW 1/4 SE 1/4, Sec. 31, T36S, R12E, WM; 10 feet South and 10 feet West from the NE corner of NW 1/4 SE 1/4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that this right is subject to prior rights to appropriate ground water from the ground water reservoir which serves as the source of this right, and should it be determined that this right has a measurable effect on the flow of Whiskey Creek and/or its tributaries, this right shall be regulated in accord with prior rights to appropriate such surface water flows, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

40.3 acres NE 1/4 NE 1/4  
 40.3 acres SE 1/4 NE 1/4  
 33.0 acres NE 1/4 SE 1/4  
 33.0 acres NW 1/4 SE 1/4  
 33.0 acres SW 1/4 SE 1/4  
 33.0 acres SE 1/4 SE 1/4  
 Section 31  
 40.4 acres SW 1/4 NW 1/4  
 Section 32  
 Township 36 South, Range 12 East, WM.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
