CERTIFICATE OF WATER RIGHT

**This is to certify, That** TOM DE ARMOND

of 11463 Broadacres Road NE, Hubbard, State of OR 97032, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Wells 1 & 2

a tributary of Mill Creek for the purpose of irrigation 111.7 acres

under Permit No. G-5568 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 23, 1972

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.39 cubic feet per second, if available at the original point of appropriation in the SE 1/4 NW 1/4 as projected within Churchill DLC 56, Section 32, T4S, R1W, WM; 980 feet North and 1650 feet East from the W 1/4 corner Section 32, or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE 1/4 NW 1/4, as projected within Churchill DLC 56, Section 32, T4S, R1W, WM; Well #1 - 980 feet North and 1650 feet East; Well #2 - 60 feet North and 1950 feet East both from the W1/4 corner Section 32,

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
