CERTIFICATE OF WATER RIGHT

This is to certify, That DONALD J. ETZEL

of 8806 Marion Road SE, Turner, State of OR 97392, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of three wells

a tributary of Mill Creek for the purpose of irrigation of 198.7 acres and supplemental irrigation of 132.5 acres

under Permit No. G-9364 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 21, 1981

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.35 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE 1/4 NE 1/4, SW 1/4 SE 1/4, SE 1/4 SE 1/4, Section 33, T8S,R2W,WM; Well 1 - 1150 feet North and 2050 feet West; Well 2 - 1170 feet North and 90 feet West; Well 3 - 3600 feet North and 1290 feet West; all from the SE corner Section 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this right, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
