## CERTIFICATE OF WATER RIGHT

This is to certify, That

J.E. AND HELEN SUTHERLAND

of Route 1, Box 370, Pilot Rock , State of OR 97868 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of McKay Creek

a tributary of Umatilla River irrigation of 31.0 acres

for the purpose of

under Permit No. 30101 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 23, 1964

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.40 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 6 (SE 1/4 NW 1/4), Lot 11 (NE 1/4 SW 1/4), Lot 10 (NW 1/4 SE 1/4), Section 1, T1S, R32E, WM; 30 feet North and 1290 feet East; 690 feet South and 1730 feet East; 1060 feet South and 2720 feet East; all from W 1/4 corner Section 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

20.8 acres Lot 11 (NE 1/4 SW 1/4)
4.0 acres Lot 12 (NW 1/4 SW 1/4)
5.2 acres Lot 10 (NW 1/4 SE 1/4)
1.0 acre Lot 15 (SW 1/4 SE 1/4)
Section 1
Township 1 South, Range 32 East, WM

This certificate is issued so as to correctly describe the place of use and supersedes certificate recorded at page 38858, Volume 30, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
