## CERTIFICATE OF WATER RIGHT

**This is to certify, That** ZABRANSKY AND SONS, INC.

of Route 1, Box 113, Stanfield, State of Oregon 97875, has made  
proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of  
Zabransky Wells 2, 1 and 3

a tributary of Stage Gulch for the purpose of  
irrigation of 708.3 acres and supplemental irrigation of 217.4 acres

under Permit No. G-8209 and that said right to the use of said waters has been perfected in  
accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from  
February 27, 1978

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is  
limited to an amount actually beneficially used for said purposes, and shall not exceed  
9.7 cubic feet per second, being 3.4 cfs from Well 2, 1.3 cfs from Well 1 and  
5.0 cfs from Well 3

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is  
located in the SW 1/4 SE 1/4, Section 24, NW 1/4 NW 1/4,  
Section 25, NE 1/4 SE 1/4, Section 36, T4N, R29E, WM; Well 2 - 160 feet North  
and 2660 feet East; Well 1 - 750 feet South and 1180 feet East, both from SW  
Corner, Section 24; Well 3 - 90 feet South and 1100 feet West from E 1/4  
Corner, Section 36.

The amount of water used for irrigation, together with the amount secured under any other right  
existing for the same lands, shall be limited to one-eightieth of one cubic foot per second  
per acre, or its equivalent for each acre irrigated and shall be further limited  
to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated  
during the irrigation season of each year,

and shall  
conform to such reasonable rotation system as may be ordered by the proper state officer.

appurtenant, is as follows:
