CERTIFICATE OF WATER RIGHT

This Is to Certify, *That* GORDON L. SCHOONOVER

of Route 1, Box 578, Oregon City, State of Oregon, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Parrot Creek

a tributary of Willamette River for the purpose of irrigation of 23.54 acres

under Permit No. 23829 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 22, 1955

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.294 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (NW 1/4 SE 1/4), Section 25, T3S, R1E, WM; North 52 degrees and 20 minutes West 2575 feet from SE corner Section 25.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

22.7 acres SW 1/4 NE 1/4
0.84 acres NW 1/4 SE 1/4
Both as projected within Vickers DLC 44
Section 25
Township 3 South, Range 1 East, WM

Land on which water is to be used is part of that described as follows:

Beginning at the SE corner of Vickers DLC 44, thence North on the East line of said claim 23.19 chains to a post; thence West 23.75 chains to a post; thence South 23.19 chains to the South boundary of said claim; thence East on said South boundary 23.75 chains to the place of beginning.

This certificate confirms the change in point of diversion authorized on September 13, 1961 by transfer application number S-142, and describes that portion of the water right confirmed by the prior certificate recorded at page 26474, Volume 18, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on March 5, 1986, approving transfer application T-5743, and NOT cancelled by the provisions of an order of the Water Resources Director entered on July 7, 1986.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
