of 12728 Gilmour Road, Jefferson , State of OR 97352 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Miller Creek and Gilmour Reservoir, constructed under Permit R-7825

for the purpose of

under Permit No. 44142 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 18, 1979

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.01 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 NE 1/4, as projected within Anderson DLC 50, Section 21, T9S, R3W, WM; 110 feet South and 1950 feet West from E corner Anderson DLC 50.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, from direct flow and storage from Reservoir constructed under Permit R-7825,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
