a tributary of Pacific Ocean irrigation of 8.2 acres

for the purpose of

under Permit No. 9600 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 29, 1930

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.09 cubic foot per second, if available at the original point of diversion, SW 1/4 NE 1/4, Section 31, T35S, RlW, WM; 70 feet North and 1400 feet West from El/4 corner Section 31

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 5, (SE 1/4 NE 1/4), Section 31, T35S, R1W, WM; 700 feet North and 365 feet West from E1/4 corner Section 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.8 acres NE 1/4 NE 1/4
6.4 acres SE 1/4 NE 1/4
Section 31
Township 35 South, Range 1 West, WM.

This certificate is issued so as to correctly describe the place of use and supersedes Certificate of Water Right recorded at page 54481, Volume 49, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
