CERTIFICATE OF WATER RIGHT

of 13327 Hwy. 234, Gold Hill , State of OR 97525 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean irrigation of 1.2 acres

for the purpose of

under Permit No. 26969 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 22, 1960

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.017 cubic foot per second, if available at the original point of diversion; Lot 5 (NW 1/4 SW 1/4), Section 11, T36S, R3W, WM; 80 feet South and 20 feet East from W 1/4 corner Section 11

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 5 (NE 1/4 SE 1/4), Section 10, T36S, R3W, WM; 270 feet South and 200 feet West from E 1/4 corner Section 10.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right to the use of water is limited to the period when the flow of the Rogue River is more than 1,000 cfs, immediately above Savage Rapids Dam and more than 735 cfs at its mouth,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 0.7 acre Lot 5 (SE 1/4 NE 1/4)

0.5 acre Lot 5 (NE 1/4 SE 1/4)

Section 10

Township 36 South, Range 3 West, WM

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered January 30, 1976, and together with certificate of water right recorded at page 43586, Volume 35, State Record of Water Right Certificates, supersedes certificate 34357, Volume 26, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
