irrigation of 21.4 acres

for the purpose of

under Permit No. 37040 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 12, 1972

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.27 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NW 1/4, as projected within T. Thompson DLC 41, Section 13, SE 1/4 NE 1/4, as projected within T. Thompson DLC 41, Section 14, Lot 11 (SW 1/4 NE 1/4), Section 14, T36S, R2W, WM; Diversion 1 - 460 feet North and 50 feet East; Diversion 2 - 770 feet West*

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

*both from E 1/4 corner Section 14; Diversion 3 - 160 feet North and 300 feet East from Center 1/4 corner Section 14.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.8 acres SW 1/4 NW 1/4 as projected within T. Thompson DLC 41 Section 13

5.4 acres Lot 11 (SW 1/4 NE 1/4)

6.1 acres SE 1/4 NE 1/4 as projected within T. Thompson DLC 41

1.9 acres Lot 8 (SE 1/4 NE 1/4)

0.2 acre Lot 10 (SE 1/4 NW 1/4)
