CERTIFICATE OF WATER RIGHT

This is to certify, That

of 8801 Highway 238, Jacksonville , State of Oregon 97530 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Sumps 1 and 2

a tributary of Applegate River supplemental irrigation of 149.2 acres

for the purpose of

under Permit No. G-7924 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 3, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

1.87 cubic feet per second with any deficiency in the available supply from Sump 1 to be made up by appropriation from Sump 2, provided the total quantity diverted from both sources shall not exceed 1.87 cfs

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NE 1/4 NE 1/4 and NE 1/4 NW 1/4 as projected within Spencer DLC 40, Section 33, T38S, R3W, WM; Sump 1- 180 feet South and 1650 feet East; Sump 2- 180 feet South and 550 feet West, both from North Quarter Corner, Section 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
