that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second, if available at the original point of diversion, SE 1/4 NW 1/4, Section 1, T37S, R7W, WM; 60 feet North and 520 feet West from C 1/4 corner Section 1

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 NW 1/4, Section 1, T37S, R7W, WM; 170 feet North and 160 feet West from C 1/4 corner Section 1. diversion is located in the

The amount of water used for irrigation, together with the amount secured under any other right one-eightieth of one cubic foot per second per existing for the same lands, shall be limited to or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, from April 2 to October 31 of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is 0.4 acre SE 1/4 NW 1/4 2.4 acres NE 1/4 SW 1/4 appurtenant, is as follows:
