CERTIFICATE OF WATER RIGHT

This is to certify, That GLENN L. ROHDE

of Route 2, Box 18, Echo, State of OR 97826, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well

a tributary of Stage Gulch (Umatilla Basin) for the purpose of irrigation of 264.6 acres

under Permit No. G-7911 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 6, 1977 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.31 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE 1/4 NE 1/4, Section 17, T3N, R30E, WM; 2300 feet South and 250 feet West from NE corner Section 17.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
