## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

MORRIS E. WILSON

of PO Box 425, Condon , State of OR 97823 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Butte Creek and unnamed drainage ways No's 1, 2, and 3

a tributary of John Day River irrigation of 42.4 acres

for the purpose of

under Permit No. 26849 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 24, 1960

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.07 cubic feet per second, being 0.93 cfs from Butte Creek, if available at the original point of diversion in the SE 1/4 NW 1/4, Section 32, T6S, R2lE, WM; 1800 feet South and 2070 feet East from NW corner Section 32, 0.03 cfs\*

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (SW 1/4 SW 1/4), SE 1/4 SW 1/4, Section 30, NE 1/4 NE 1/4, NW 1/4 NE 1/4, NE 1/4 NW 1/4, Section 31, SE 1/4 NW 1/4, Section 32, T6S, R21E, WM; Unnamed drainage way #1 - 1050 feet South and 1550 feet West; Unnamed drainage way #2 - 240 feet South and 2350 feet West; Unnamed drainage way #3 - 10 feet South and 3030 feet West;\*\*

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

\*from unnamed drainage way #1, 0.03 cfs from unnamed drainage way #2, and 0.08 cfs from unnamed drainge way #3

\*\*Butte Creek - 1800 feet South and 2070 feet East, A - 1300 feet North and 4440 feet West, B - 270 feet North and 2980 feet West, C - 170 feet South and 1940 feet West, D - 610 feet South and 1180 feet West; all from NE corner Section 31.
