CERTIFICATE OF WATER RIGHT

This is to certify, That CLIFFORD W. AND DARLENE J. STEVENS

of 80972 Territorial Road, Eugene, State of OR 97405, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of unnamed stream and Stevens Reservoir constructed under Permit R-8385

a tributary of North Fork Siuslaw River for the purpose of irrigation of 0.5 acre, supplemental irrigation of 1.5 acres and maintenance of Stevens Reservoir for fire protection under Permit No. 46582 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 30, 1982

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.025 cubic foot per second for irrigation and 0.005 cfs for maintenance of reservoir for fire protection, the total diversion shall not exceed 0.025 cfs

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 SE 1/4, as projected within Crow DLC 38, Section 1, T20S, R5W, WM; 900 feet North and 160 feet West from SE corner Crow DLC 38.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
