CERTIFICATE OF WATER RIGHT

This is to certify, That JAMES BUTSCH

of 15234 Butsch Lane NE, Mt. Angel , State of OR 97362 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of wells #1 & #2

a tributary of Mill Creek irrigation and supplemental irrigation of 166.5 acres

for the purpose of

under Permit No. G-8563 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 7, 1979

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.09 cubic foot per second; being 0.31 cfs from well #1 with any deficiency to be made up from well #2 and 1.78 cfs from well 2

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NW 1/4 NW 1/4, Section 27, SW 1/4 NE 1/4, Section 28, both as projected within Hovendon DLC 76, T4S, R1W, WM; Well 1 - 1340 feet North and 1450 feet West from Center corner Section 27; Well 2 - 430 feet North and 1200 feet East from Center 1/4 corner Section 28.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
