6532 Howell Prairie Rd., Silverton OR 97381 , State of , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of one well

Little Pudding River a tributary of irrigation of 94.0 acres

for the purpose of

G-9933 under Permit No. and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 27, 1982

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.62 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is the NW 1/4 SW 1/4, as projected within W. Howell DLC 46, Section 26, T6S, R2W, WM; 510 feet South and 750 feet East from SW corner Woodward DLC 96.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
