## CERTIFICATE OF WATER RIGHT

This is to certify, That

THEODORE R. TIAHRT

of Star Route, Silverlake , State of OR 97638 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two wells

a tributary of Fort Rock Basin supplemental irrigation of 520.0 acres

for the purpose of

under Permit No. G-7481 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 4, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.4 cubic feet per second; being 1.4 cfs from well #2 and 3.0 cfs from well #3

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NE 1/4 NE 1/4, NW 1/4 SE 1/4, Section 22, T26S, R15E, WM; #2 - 1300 feet South and 1130 feet West from NE corner Section 22; #3 - 2560 feet North and 2725 feet East from SW corner Section 22.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
