CERTIFICATE OF WATER RIGHT

This is to certify, That DR. MARK A. MELGARD

of 1296 Commercial SE #103, Salem, State of OR 97302, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a spring, unnamed streams 1, 2, 3, Melgard Lake Reservoir, and a stock pond, constructed under Permit R-6072

a tributary of Willamette River for the purpose of irrigation of 20.8 acres, stock barn, and domestic use for one family including the irrigation of lawn and garden not to exceed 1/2 acre in area under Permit No. 37384 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 14, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.275 cubic foot per second; being 0.26 cfs from Streams 1 and 2, and Melgard Lake Reservoir for irrigation; 0.005 cfs from Spring for domestic and 0.005 cfs from Spring for stock barn, and 0.005 cfs from Stream 3 and pond for stock

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Stream 1 and Melgard Lake Reservoir - SW 1/4 NE 1/4, Stream 2 - SE 1/4 NE 1/4, Stream 3 and stock pond - SW 1/4 NE 1/4, Spring - NW 1/4 NE 1/4, Section 26, T8S, R4W, WM; Stream 1 and Melgard Lake Reservoir - 980 feet North and 1740 feet West; Stream 2 - 950 feet North and 50 feet West; Stream 3 and stock pond - 100 feet North and 1450 feet West; *

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-6072,

*Spring - 1450 feet North and 2050 feet West all from E 1/4 corner Section 26. and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
