that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.71 cubic foot per second; being 0.13 cfs from 413; 0.20 cfs from 414; 0.18 cfs from 416; 0.20 cfs from 421

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the 421; Lot 5 (SW 1/4 SE 1/4), Section 23, 414; SW 1/4 NE 1/4, Section 26, 413; Lot 10 (SE 1/4 NE 1/4), Section 26, 416; Lot 2 (NE 1/4 NE 1/4), Section 35, T9S, R4W, WM; 1900 feet North and 1750 feet West; 230 feet South and 980 feet West; 710 feet South 510 feet West from SW corner Wood DLC 55; 470 feet South and 1320 feet West from NE corner Section 35.

conform to such reasonable rotation system as may be ordered by the proper state officer.
